# BACKGROUND


Association of Professional Social Workers and Development Practitioners (APSWDP) aims at engaging students for internship and also for block fieldwork from various sectors across the country and abroad with an objective to allow young talent from reputed institutions to be associated with us to get engaged in our professional network, learn professional values and practices with mentors and professional experts associated with the association.

During COVID-19 Pandemic, the sudden nationwide lockdown has made life standstill and worst hit, be it is livelihood or education. The pandemic has given a thought to evolve an alternate mechanism to move on within the environmental limitations and availability of resources. It has made to learn and adopt available ICTs viz. virtual meetings, classes, and training which was a far reality in a country like India.

During the pandemic, the Department of Social Work, Chaudhary Bansi Lal University, Bhiwani approached the association to conduct virtual internships for the Masters in Social Work (MSW) students due to lockdown and mentor them on social work practices, skills and methods.

Keeping in view the pandemic in mind and the association's mandate, the APSWDP decided to launch the Virtual Internship Programme for the first time under the dynamic leadership of Dr. Sumit Arora, Hon. Director, Capacity Building and Training.

An Internship Program Structure of four weeks duration was developed, in which 15 hours of virtual sessions and forty hours of weekly fieldwork activities under the supervision of respective university supervisors were structured. The internship course work was comprised of an Induction program, virtual technical and transactional learning sessions, participation in panel discussions, virtual and physical projects (depending on the nature of guidelines on movement by state) and digital field reports, etc.



# OPENING CEREMONY AND INAUGURAL

### . OPENING CEREMONY AND INAUGURAL

**Welcome Session:** Mr. Hitesh Kumar Gulati, Hon. Director Administration and Policy, APSWDP extended his gratitude to the Guest, Experts present, faculties, and students from the Department of Social Work, Chaudhary Bansi Lal University, Bhiwani, Haryana, and formally welcomed them. He further shared that the kind of virtual internship program during the COVID 19 pandemic was developed by the association at very short notice and request from Mr. Mool Raj Verma, Assistant Professor, CBLU, Bhiwani.

**Introductory Session:** Dr. Sumit Arora, Hon. Director Capacity Building and Training, APSWDP shared about the conception of the APSWDP Virtual Internship Programme especially for the Masters of Social Work (MSW) students of Department of Social Work, Chaudhary Bansi Lal University, Bhiwani, Haryana.



He defined internship as "any official or formal program to provide practical experience for beginners in an occupation or profession."

Dr. Geetika Malhotra and Mr. Mool Raj Verma, Faculties from Department of Social Work, Chaudhary Bansi Lal University, Bhiwani, Haryana have shared about the nature and background of MSW students in addition to their engagement in community and organizational settings during their first-year course. Both of them also stressed and directed students to adhere to the norms and requirements of the university and APSWDP internship guidelines.

**Inaugural Session:** Mr. Vivek Trivedi, Founder APSWDP and globally known Social Development Expert in the social work sector inaugurated the first Virtual Internship Programme of APSWDP for the MSW students of CBLU, Bhiwani. He appreciated the combined efforts of Mr. Mool Raj Verma, Dr. Geetika Malhotra, and Mr. Jitender Lohia to work in coherence with the team of APSWDP in finalizing the virtual internship program amid the COVID-19 Pandemic. He also appreciated and admired the efforts of Dr. Sumit Arora for taking a lead in devising the APSWDP Internship policy. He further shared that the most important element of internships is that it integrates classroom knowledge and theory with practical application and skills developed in professional or community settings. It also brings a wealth of benefits to students, both while completing a degree and when seeking a career path post-graduation.

# VIRTUAL TECHNICAL SESSIONS AND PANEL DISCUSSION

**Induction Session:** In the Induction session, Dr. Sumit Arora, Hon. Director Capacity Building and Training, APSWDP, and Mr. Mool Raj Verma, Assistant Professor, CBLU, Bhiwani during the induction session shared the structure of the internship program with the students and guidelines in detail on General Instructions to be followed, preparation, and drafting of reports. The following instructions and suggestions were given to the students:-

1. Intern shall choose an area of social work practices along with a choice of method of social work to be practiced during the internship.

2. If an intern would like to carry an empirical study then, s/he should plan a topic of their study, universe of the study and sample size in consultation with their respective faculty in charge.



3. If an intern would like to practice primary methods of social work then they are supposed to undertake case studies from their neighborhood/ immediate vicinity keeping in view the COVID-19 pandemic guidelines issues by their respective Areas/ States etc.

4. Interns can observe and follow the guidelines of the Government towards their own personal safety. For example, observing social distancing, wearing 3 layered masks, and using hand sanitizer/ washing hands with soap.

5. In addition, if interns are facing any kind of problems in making the physical visits in their vicinity, then they can plan the study through secondary sources by accessing web-based available resources.

6. Interns are required to compile detailed studies of any eight organizations (2 every week) including 4 nationally known, 4 globally known including (Government and Non-Government).

7. A short presentation on the respective topic has to be made by each intern on any day fixed in consonance with the faculty members.

8. Upon successful completion of the 4 weeks internship course, APSWDP will issue a certificate of internship to those who have ensured 100 percent attendance throughout, duly verified by the respective faculty in charge.








### **Reporting requirements:**

Interns are required to observe the following instructions while preparing their reports.

A. Cover page

B. Indexing

C. Abbreviations

D. Induction meeting report

E. Detailed report of eight organizations (maximum 2 pages each).

F. Four case studies with respect to methods chosen by them (maximum 2 pages each including one picture each)

G. Four national/ state missions of the government to be studied by the interns and the same are required to be documented (maximum 2 pages each).

H. Two national-level policies related to environment/ poverty/ employment/ social welfare/ others are required to be studies by the interns and the same to be documented (maximum 5 pages each).

3. It is mandatory for all the interns to study Niti aayog, its functions, roles, programs, policies, structure, etc. In detail (maximum 10 pages).


4. Interns must keep in mind while doing internet research that the contents should not be copy paste and rather they should be developed in their own language.






