

Background of WSWD-2021

Background of WSWD 2021

World Social Work Day (WSWD) was launched by The International Federation of Social Workers (IFSW) in 1983. Later, other social work organizations such as the International Association of Schools of Social Work (IASSW) have also joined as partners to this event. WSWD has become a focal point in the social work calendar with social workers all over the world celebrating and promoting the contributions of the profession towards individuals, families, communities, and wider society. The day is celebrated every 3rd Tuesday of March.

On this day, social work organizations throughout the world celebrate WSWD by the way of bringing messages to their governments, communities, and peer professional groups on the unique and significant contributions made by the social work profession. The actions also highlight the approach of the social work profession to facilitate sustainable community outcomes by applying a developmental and capacity building approach coupled with advocating for social justice and human rights.

The themes of WSWD are set for two years according to the goals of the Global Agenda for Social Work and Social Development:

2012 - 2014: Promoting Social and Economic Equality

2015 – 2016: Promoting the Dignity and Worth of Peoples.

2017 – 2018: Promoting Community and Environmental Sustainability

2019 – 2020: Promoting the Importance of Human Relationships

2020 – 2021: Strengthening Social Solidarity & Global Connectedness

Every year IFSW produces a poster announcing WSWD which is spontaneously translated into over 45 languages, and presented to governments, political bodies posted on the notice boards of social services and in social work classrooms throughout the world. The event has become so successful in recent years it is now generally considered as a highlight of international solidarity and cooperation of social workers.

WORLD SOCIAL WORK DAY AT THE UNITED NATIONS

IASSW and IFSW have special consultative status with the United Nations Economic and Social Council (UN-ECOSOC) (IASSW since 1947 and IFSW since 1959). Jointly the representatives of both organizations have annually celebrated WSWD at the UN in New York since 1983 and in Geneva since 2012. Sporadically WSWD at the UN has also been celebrated in Vienna, Nairobi, and Santiago de Chile. In 2017 for the first time, WSWD &as celebrated at the UN in Bangkok.

OBJECTIVES OF WSWD AT THE UN

- 1. To strengthen existing or to establish new contacts, cooperation, and partnership with UN organizations and with allied international NGOs.
- 2. To spread knowledge about social work, its values, principles, and methods in practice and theory among UN organizations and allied international NGOs.
- 3. To highlight social work actions, policies, and achievements in the pursuit of common goals.
- 4. To disseminate the knowledge about UN activities, goals, programs and campaigns among social workers and social work organizations, and schools.

WORLD SOCIAL WORK DAY AT CHANDIGARH

Association of Professional Social Workers and Development Practitioners (APSWDP), Alliance of Professional Social Workers commemorated World Social Work Day 2014 for the first time in Chandigarh tri-city region at IGNOU Regional Centre among Professional Social Workers, undergraduate and Post Graduate Social Work Students, practitioners and IGNOU counsellors under the mentorship and guidance of Mr Vivek Trivedi and Dr J. K. Yadav. Later, inspired by the successful organisation of World Social Work Day for the first time in the region, a giant leap was taken in conceiving formal and legal set up of Association of Professional Social Workers and Development Practitioners in 2014.

The first official debut of commemorating World Social Work Day 2015 in the entire northern region was made under the mentorship and invitation from the renowned social worker and the then His Excellency Prof. Kaptan Singh Solanki, Hon'ble Governor, Punjab and Haryana, the Administrator, U.T. Chandigarh at Raj Bhawan, U.T. Chandigarh.

Since then, APSWDP is celebrating consecutively World Social Work Day at Chandigarh by involving leading and premier government and non-government institutions more prominently, State Legal Service Authority, U.T. Chandigarh, District Legal Service Authority, Chandigarh, Rajiv Gandhi National Institute of Youth Development, Regional Centre, Chandigarh, Govt. of India, School of Public Health, PGIMER, Chandigarh, Centre for Social Work, Panjab University, Chandigarh, Punjab Energy Development Agency (PEDA), Punjab Tourism Department, The Climate Reality Project India, Municipal Corporation, Chandigarh, Union Bank of India, RO, Chandigarh etc. in past.

Vikas Verma, Regional Head, SDG CC UNDP India, and Distinguished Guest Sh. Ashok Kumar Mann CJM-cum-Secretary, District Legal Service Authority (DLSA), Chandigarh and Principal Convener WSWD-2021 Shri Vivek Trivedi.

He has also introduced the background of work and experiences of the chief guest, guest of honor and distinguished guest on dais.

Vikas Verma, Regional Head, SDG CC UNDP India, Special Guest Shri Ashok Kumar Mann, CJM-cum-Secretary DLSA Chandigarh, Principal Convener WSWD-2021, Shri Vivek Trivedi, invited guests, other distinguished guest presents, along with the key functionaries of Association of Professional Social Workers and Development Practitioners (APSWDP) escorted by Shri. Rajeshwar Singh, Dr. Sumit Arora, Ms. Poornima Bhardwaj, Adv. Gautam Bhardwaj and Shri. Neil Roberts.



First time, a song with poetic verses "Ye Kaun Chitrakar Hai" was played during the lamp lighting ceremony to mark respect and homage to Nature and sources of energy.

Programme Background and Introduction by Shri. Vivek Trivedi, Principal Convener, WSWD-2021



Mr. Vivek Trivedi, while sharing the programme background, he briefed that "World Social Work Day (WSWD)" was launched by The International Federation of Social Workers (IFSW) in 1983 and later, other social work organizations such as the International Association of Schools of Social Work (IASSW) have also joined as collaborative partners to popularize the day worldwide. He said that WSWD has become a focal event in the global calendar of social work and social workers all over the world for celebrating and promoting the contributions of the social work profession towards individuals, families, communities, and wider society. The day is universally celebrated every 3rd Tuesday of March. He said that on this day, social work organizations working in diverse domain of development sector throughout the world celebrate WSWD by way of bringing messages to their governments, communities, and peer professional groups on the unique and significant contributions made by the social work profession. The actions also highlight the approach of the social work profession to facilitate sustainable community outcomes by applying a developmental, capacity building and convergence approach coupled with advocating for social justice and human rights.

He further briefed that APSWDP has been conferred Special Consultative Status with the United Nations Economic and Social Council (UN-ECOSOC) and affiliation with UN Department of Global Communications in 2019. He asserted that APSWDP is organizing the day in the Chandigarh region for the past 6 years with the government departments, civil society and youth networks. He has also thrown light on International Day of Happiness (IDH) and shared that the United Nations is celebrating the IDH as a way to recognize the importance of happiness in the lives of people around the world. In 2015, the UN launched the 17 Sustainable Development Goals, which seek to end poverty, reduce inequality, and protect our planet – three key aspects that lead to well-being and happiness.

World Social Work Day 2021: Comprehensive Report

Shri Trivedi recalled that the General Assembly of the United Nations in its resolution 66/281 of 12 July 2012, proclaimed 20 March as the International Day of Happiness, recognizing the relevance of happiness and well-being as universal goals and aspirations in the lives of human beings around the world and the importance of their recognition in public policy objectives. It also recognized the need for a more inclusive, equitable, and balanced approach to economic growth that promotes sustainable development, poverty eradication, happiness, and the well-being of all peoples. He further added that the resolution was initiated by Bhutan, a country that recognized the value of national happiness over national income since the early 1970s and famously adopted the goal of Gross National Happiness over Gross National Product.

He also shared that the key objectives of commemorating such day are to strengthen existing or to establish new contacts, cooperation and partnership with diverse organizations and stakeholders; spread knowledge about social work, its values, principles, and methods in practice and theory among organizations and departments; highlight social work actions, policies, and achievements in the pursuit of common goals; disseminate the knowledge about SDGs, program, and campaigns among social workers, community workers and social work organizations, institutions and establishing convergence among them for bringing efficacy in developing communities; and discuss specific NALSA schemes with various workforces engaged in the development process at the community level.

In his concluding words, he said that APSWDP has a firm belief in "Think Global and Act Local" and is committed to disseminating global knowledge and practices learned and acquired from UN conferences, training workshops, and TOTs especially at UNITAR/CIFAL JITC. He assured that APSWDP will always work on evolving way forward by converging and developing linkages with Social Work Professionals and law professionals to work in coherence for resolving human conflicts in the communities; integrating methods of social work in practice with law-abiding and enforcement agencies; promoting community-driven development on the principles of participation, local empowerment, demand-responsiveness, greater accountability and enhance local capacity through transparency; mainstreaming of various civil society organizations, non-governmental organizations to lead the local chapter in Chandigarh; enhancing the outreach activities through a participatory approach to empower people through NALSA scheme in a pursuit to improve their overall wellbeing; and emphasizing on introducing the concept of change management and sustainable lifestyle.

He shared that SLSA Chandigarh has always been proactive in supporting APSWDP for organizing such knowledge disseminating training workshops for diverse stakeholders.

Address by Guest of Honor Shri. Vikas Verma, Regional Head North, SDGCC, UNDP India.



Shri Vikas Verma started his session by appreciating the concerns of volunteers, members, and professionals who were present in the workshop irrespective of the day being a holiday for most. He congratulated Mr. Vivek Trivedi to organize such a great event and Mr. Mahavir Singh for rendering institutional support. He applauded the concerns of all the social workers and development practitioners present in the workshop.

He put in brief about the foundation of the United Nations which has also been trying to deal with the issues before they emerge. He shared that the United Nations works in 170 countries at the field level to know as to where the world is going. He further added that when Millennium Development Goals were introduced during the start of the 20th century, it was through that may be when we focus on the issues together and we could address the issues globally. However, the applicability of the MDGs was not at the nations as compared to SDGs which is a follow-up exercise of the MDGs.

He further shared that SDGs started in January 2016 when 193 countries signed and accepted these goals. The beauty of SDGs is that it does not stop at few countries that were supposed to take the agenda of MDG ahead. The SDGs does not differentiate between the countries as it takes into account all the countries, governments, panchayats, institutions, organizations, etc. Unlike MDGs, SDGs are also applicable to all the developed nations around the globe to the most developed persons around the globe. To craft SDGs, a three years-long consultative process took place, in which across the board with various organizations, institutions, CSOs, women groups, governments, children, small countries, leaders and intellectuals put together their minds and this is how the SDGs came into existence. It has a butterfly effect which means that any action taken by one gives an impact on the entire world. He narrated it with an example of a ripples effect that could reach the shore, Shri Verma added.



Further, he mentioned that the concept of UBUNTU is not new to us. He recited a Sanskrit phrase "Vasudhaiva Kutumbakam" inscribed in the Hindu mythological books which means 'the world is one family' which is the starting point for the SDGs. I am not alone as an individual but connected to everyone. It connects both the points of community-driven development and convergence, how SDGs are trying to take up together. We all are trying to make difference through our own ways.

He also shared the concept of change which must start from the individual level and must reach to the community and for which the concept of community driven development is much required. He clarified that all the 17 goals touch our lives and we require Integration, convergence, joining hands, and need the help of the entire community to achieve the goals.

He asserted that **Leaving no one behind** means the last man standing in the row gets the rights and their needs fulfilled should be the soul axiom of our actions. He said that individuals should be empowered to take action and to develop themselves without having a dependency on others. Lastly, he concluded by saying that the Sustainable Development Goals (SDGs) are human-centric and he appreciated the work of the State Legal Services Authority (SLSA), which involves the community through the paralegal volunteers, community-based organizations, and panel lawyers who are visiting the community and it itself propagates community to drive development approach and connects SDGs.

Address by Chief Guest Shri. Mahavir Singh, ADJ-cum-Member Secretary SLSA, Chandigarh.



Shri Mahavir Singh, ADJ -cum- Member Secretary, State Legal Services Authority (SLSA) Chandigarh started his session by greeting all the guests and key persons sitting on the dais namely Shri Vikas Verma, Shri Ashok Kumar, and Shri Vivek Trivedi. He also acknowledged the presence of representatives from various organizations, advocates, professionals, students present during the training.

Shri Singh referred to the address made by Shri Vikas Verma regarding the United Nations Sustainable Development Goals (SDGs) and emphasized on the role of State Legal Services Authority (SLSA) which is also similar to these roles. He mentioned about the NALSA scheme and the benefits given to individuals and families under these schemes through community led approach. These schemes are facilitated by the para legal volunteers at the field level. He mentioned that most of the SDGs correlate with these schemes.

For instance, schemes for poor people, women and senior citizens, unorganized labour, weaker section of society, persons with disabilities, special scheme for victims of acid attack, and finally various schemes dealing with any kind of pandemic situation which can also be taken under the category of disaster management. All these schemes cover most of the Sustainable Development Goals of the United Nations and SLSA is very successfully implementing such schemes at Chandigarh level which is a part of the individual as well as team efforts and with the support from various community led organizations and civil society organizations. He referred to the dark time of COVID-19 situation while the entire country was under complete lockdown, and nothing was functioning. At that time Chandigarh Administration did very well and joined hands with various CSOs and Religious Organizations in Chandigarh. Under this campaign, various articles such as food, essential items were provided to those in necessity.

Considering the needs of the children who are trapped inside the houses, several books were also provided to the children to eradicate their boredom. It was a joint project which was executed under the umbrella of State Legal Services Authority (SLSA) Chandigarh and supported by Chandigarh Administration., he referred.

He also recalled that during the COVID-19 lockdown, SLSA had received a telephonic request from the region of Jammu & Kashmir for providing humanitarian assistance to a group of 16-17 Kashmiris who were stranded in Chandigarh. With full determination and zeal, the volunteers of the Association of Professional Social Workers and Development Practitioners (APSWDP) went to the site for providing psycho-social counselling and essential items. The volunteers left no stone unturned to provide them frequent support by visiting them for more than one months till they were not travelled back to their destination. With all due support received from various administrative channels, all 16-17 Kashmiris were safely shifted to their native areas which was a remarkable experience of dealing human kind during the tough times of COVID-19.

He narrated initiatives of PGIMER, which is one of the best medical institutions in the country and many patients who were getting treatment from these institutions could not visit due to a lockdown situation. Many of them were not able to get their medications in their respective areas. These requests were also entertained and subsequently, medications were sent to the State of Jammu & Kashmir, Himachal Pradesh, and Uttrakhand.

Due to restrictions in the movement of persons, cases of domestic violence were reported at large. To deal with the cases expeditiously, SLSA started a 24x7 helpline. The matter was taken up with NALSA and the telecommunications department and finally, the helpline was transferred to State Legal Services Authority (SLSA). The decision was taken so that the cases may be dealt by a responsible person with the hope of providing the best possible services to the needy.

By mentioning the theme of this WSWD 2021 'I am because we are', he stated that we all have to work jointly and closely to accomplish our aims and ambitions. He also mentioned that the government can be successful in implementing the schemes and support individuals from all walks of life only if the citizens of this country support them.

Shri Singh also elaborated that since 2018, SLSA has been organizing 'Legal Empowerment Camps' after the localities are identified by para legal volunteers. A pre-camp survey is conducted to know the issues faced by the residents and thereafter the concerned departments are contacted to ensure the remedial measures to be provided.



He referred youngsters who are interested to undergo skill development courses were guided for getting themselves registered with various Government of India schemes.

He also took this opportunity to mention that Social Work has now been recognized by State Legal Services Authority, as we all are endeavoring to achieve the same goals. He talked about the concept of convergence and for which the role of civil society organizations, state legal services authority, and organizations of similar stature is increasing manifold. He also mentioned that SLSA is also working similar to a non-governmental organization which gives much freedom to work at the community level and with various governmental departments.

Finally, he mentioned that the role of Civil Societies has been recognized everywhere. The representative of CSO is also called by the government so that the voices can be raised and heard. The World Social Work Day is celebrated on the 3rd of every Tuesday of March but it is being celebrated on the 13th March 2021 Saturday so that all the professionals working in various departments and sectors can join and participate. He appreciated the good work done by the APSWDP and their volunteers.

Community Driven Development in context of NALSA Scheme

Technical Session - I: Community Driven Development in context of NALSA Scheme

Mr. Rajeshwar Singh, Law Officer, State Legal Services Authority (SLSA), Chandigarh in his technical session on the Role of SLSA and NALSA Scheme shared the following functions and role:-

- to provide legal service to persons who satisfy the criteria laid down in the Legal Services Authorities Act, 1987,
- to conduct Lok Adalats at various levels,
- to encourage the settlement of disputes by way of Negotiation, Arbitration, and Conciliation,
- to secure the legal rights of the poor, downtrodden, and weaker section of the society,
- to ensure that the operation of the legal system promotes justice on a basis of equal opportunity,



- to give people a platform where they receive effective counseling in order to resolve their disputes in an amicable manner and at the pre-litigation stage,
- to carry out a legal literacy campaign,
- to publicize legal aid schemes so that the target group, for whom Legal Services
 Authorities Act has provided for free legal aid, may come to know about the same
 and approach the concerned legal service functionaries,
- to make special efforts to enlist the support of voluntary social welfare institutions working at the grass-root level, particularly among the Scheduled Castes and Scheduled Tribes, Women, and Rural and Urban labor,
- to act in coordination with other governmental agencies, non-governmental voluntary social service institutions, universities, and other bodies engaged in the work of promoting the cause of legal services to the poor,
- to sensitize people about the aims and objectives of the Legal Services Authorities Act, 1987 and their legal rights.

In continuation to the technical session by Shri Rajeshwar Singh, Shri Vivek Trivedi further connected the session on the role of SLSA with Community-Driven Development. In his session, he first threw few questions on Community, Community Development, and Community-Driven Development. He clarified first that the participants should come up with their understanding of the terms referred by him on community development. Afterward, he shared definition following definition on community and community development as under:-

"The person who is independent of his fellow beings and is unable to live in community or society is either Beast or God. Community is the combination of two Latin words i.e. 'cam' means together and 'munis' means serve i.e. .serve together is called the community" - **Socrates.**

"Total organization of social life within a limited area" - W. Ogburn

"a process where community members come together to take collective action and generate solutions to common problems." - **United Nations**

He further referred to another definition of Community Development propagated by the International **Association** of **Community** practice-based **Development** (IACD), "a as profession and an academic discipline that promotes participative democracy, sustainable development, rights, economic opportunity, equality, social iustice. through and organization, education, and empowerment of people within their communities, whether these be of locality, identity or interest, in urban and rural settings"





Shri. Vivek Trivedi referred to the World Bank and ADB's understanding of Community-driven development (CDD). He cited another definition of CDD as a development initiative that provides control of the development process, resources, and decision-making authority directly to groups in the community. The underlying assumption of CDD projects is that communities are the best judges of how their lives and livelihoods can be improved and, if provided with adequate resources and information, they can organize themselves to provide for their immediate needs. CDD projects work by providing poor communities with direct funding for development with the communities then deciding how to spend the money. Lastly, the community plans and builds the project and takes responsibility for monitoring its progress.

He further highlighted that Community Driven Development (CDD) approaches aim to empower people in poverty by putting investments and responsibility for decision making in their hands. In so doing, CDD works to build opportunities, strengthen the people's voice to demand greater accountability of the institutions that are relevant to their livelihoods, and to promote sustainable development.

Shri Trivedi in his later half of the technical session highlighted the following principles developed by the Social Development Department, World Bank in a publication on "Community Driven Development: Broadening Community Authority and Control Over Decisions and Resources" to enhance the effectiveness and sustainability of CDD policies, programme design, and implementation:-

- **1. Make investments responsive to informed demand:** Programme rules should facilitate informed choice so communities can select priority options and enterprises that are within their capacity and that they can afford to operate in the long run.
- 2. Build participatory mechanisms for community control and stakeholder involvement: Involvement of all stakeholders should be sought throughout all phases of the CDD project cycle.
- **3. Invest in capacity building of community-based organizations (CBOs):** Building the capacity of CBOs and fostering relationships with formal support institutions are productive investments in themselves, but should include explicit exit strategies.
- **4. Facilitate community access to information:** Facilitating flows of information with all groups in a community in terms of programme contents and rules, linkages with government and markets, and good practices of CBOs is an essential component of CDD.
- **5.** Develop simple rules and strong incentives supported by monitoring and evaluation: Community access to resources should be governed by simple rules and procedures that are easy for communities to interpret and apply. Participatory monitoring and evaluation is an important tool for community assessment of its own performance.
- 6. **Establish enabling institutional and policy frameworks:** Fostering an enabling environment includes (i) responsive decentralized local, governments and intergovernmental arrangements; (ii) a conducive legal and regulatory framework that supports community action; and (iii) clear sector, policies with well-defined roles and responsibilities for key players in each sector.
- **7. Maintain flexibility in the design of arrangements and innovation:** Programme design should be reviewed and adjusted periodically, as necessary. Procedures should ensure direct feedback from the community on programme performance that can feed into project restructuring.
- **8. Ensure social and gender inclusion:** Explicit gender-sensitive approaches are needed to ensure that CBOs incorporate the interests of groups that are often excluded, including women, minority groups, remote communities, and the poorest women and men.
- **9. Design for scaling-up:** To have a broader impact on a country's poverty, CDD needs to spread simultaneously in many communities, while respecting the unique features of specific communities.
- **10. Invest in an exit strategy: Exit strategies for external support are vital:** Permanent institutional and financial arrangements are required for recurrent services, at a cost that can be supported over the medium and long term.

In the last, he concluded by referring to examples from the Indian context viz. Social Mobilization and Institutional Development (SMID) component of National Urban Livelihood Mission, Targeted Intervention projects under State AIDS Control Societies under NACO.

Technical Session - II: Sustainable Development Goals (SDGs) and its Localization



Dr. Sumit Arora shared in his presentation about the Sustainable Development Goals (SDGs) and their localization at the community level. He said that SDGs are also known as the Global Goals, which were adopted by all United Nations Member States in 2015 as a universal call to action to end poverty, protect the planet and ensure that all people enjoy peace and prosperity by 2030.

He highlighted the key feature of the 17 SDGs as their **Integration and Connectedness**. He further said that 17 SDGs are integrated—that is, they recognize that action in one area will affect outcomes in others and that development must balance social, economic, and environmental sustainability.

Dr. Arora in his deliberation referred that through the pledge to "Leave No One Behind", countries have committed to fast-track progress for those furthest behind first. That is why the SDGs are designed to bring the world to several life-changing 'zeros', including zero poverty, hunger, AIDS, and discrimination against women and girls.

Further, he elaborated on each of the SDGs one by one using SDG models with participants and discussed in detail about its targets and sub-targets. Later, he also introduced about his involvement in UNITAR/CIFAL Jeju as participants in their workshops on the Localization of SDGs and others on COVID-19 impacts, where he learned about this innovative concept on Community Driven Development and SDGs. He further added that he has taken SDGs awareness at a local level with school children, school drop-outs, college and university youth through Youth Parliaments on SDGs under the aegis of APSWDP since its inception. He also shared that APSWDP will come up with the SDG Literacy concept and SDG Literacy clubs in the educational institutions in the coming future and request participants to volunteer their time for the same.

Action Plan and Way Forward

In order to ensure Community Driven Development at grass root level under the ambit of Sustainable Development Goals (SDGs), all the participants have worked in four working groups on four various themes corresponding to aspects of community-driven development and SDGs. The recommendations of four groups have evolved following action plan for making remarkable improvement in the development process at the community level by referred stakeholders:-

- Involving Religious & Community Based Organizations and their Representatives and Community Leaders **Government agencies**.
- Innovating by the use of caller tunes, Nukkar Nataks/ Flash mobs at Traffic lights and in educational institutions including schools, colleges, and universities - All stakeholders.
- Conducting regular Community Needs Assessment Surveys Civil Society Organizations.
- Linking relevant SDGs with various legal aid NALSA schemes SLSA/NLSA.
- Involving Corporates, Industries, and Public Sector Undertakings under Corporate Social Responsibility (CSR) Act Federations of Industries and Corporates.
- Empowering grass-root workers namely ASHA workers, Anganwadi Workers, Women CBOs, etc. Social Welfare Department and DAY-NULM Municipal Corporation.
- Establishment of community advisory board for redressal of the grievances at Local and Community Level **Elected Councilors and Government Agencies**.
- Community campaigns and drives on various social issues within the community -CBOs, NGOs.
- Sensitization programs for all stakeholders from time to time including that of Trade Unions/CBOs and Youth Organizations **Government Agencies**.
- Formation of Self Help Groups, Community Based Organizations under Non-Governmental Organization category for developing community leadership and corresponding development- **DAY NULM Municipal Corporation.**
- Linkages with Governmental departments/ allied development agencies, NGOs and global organizations, and Corporates for partnership building and knowledge development All stakeholders.
- Community consultations with the change agents such as youth and area leaders, influential and religious group leaders CSOs.
- Identification of various parameters that ensure physical, mental, and social well-being of the community members by the way of meetings, talks, focused group discussions at various fronts- **Research Institutions**.

Action Plan and Way Forward

- Mainstreaming with the judicial and executive system to ensure resolution of all conflicts, whether at regional, national, or international levels- Inter-governmental agencies and Bar Councils.
- Partnering with various civil society organizations, community-based organizations, religious/faith-based organizations, networks of youth and volunteers, etc. for community development projects and shared funding - DAY-NULM, NRLM, and other national missions.
- Mainstreaming with various health agencies, CSOs, CBOs for ensuring support through different channels - Local Government.
- Collaborating with the educational department for ensuring education at the primary level by the way of involving CSOs, panchayat members, SDM/ Collector, Pradhan of that particular area on SDGs. Working on Localization of SDGs and SDG Literacy by creating SDG literacy clubs - State Government.
- 18 Ensure that women are provided with a safe working environment to have legal support; special provision for women in problems, victims of sexual harassment, etc. for providing them immediate relief - SLSA, Police Department, and Women Commissions.
- 19 Employment generation programs with the Department of Labour especially during times of disasters which will enable the youth to participate and support their family - District Administration.












