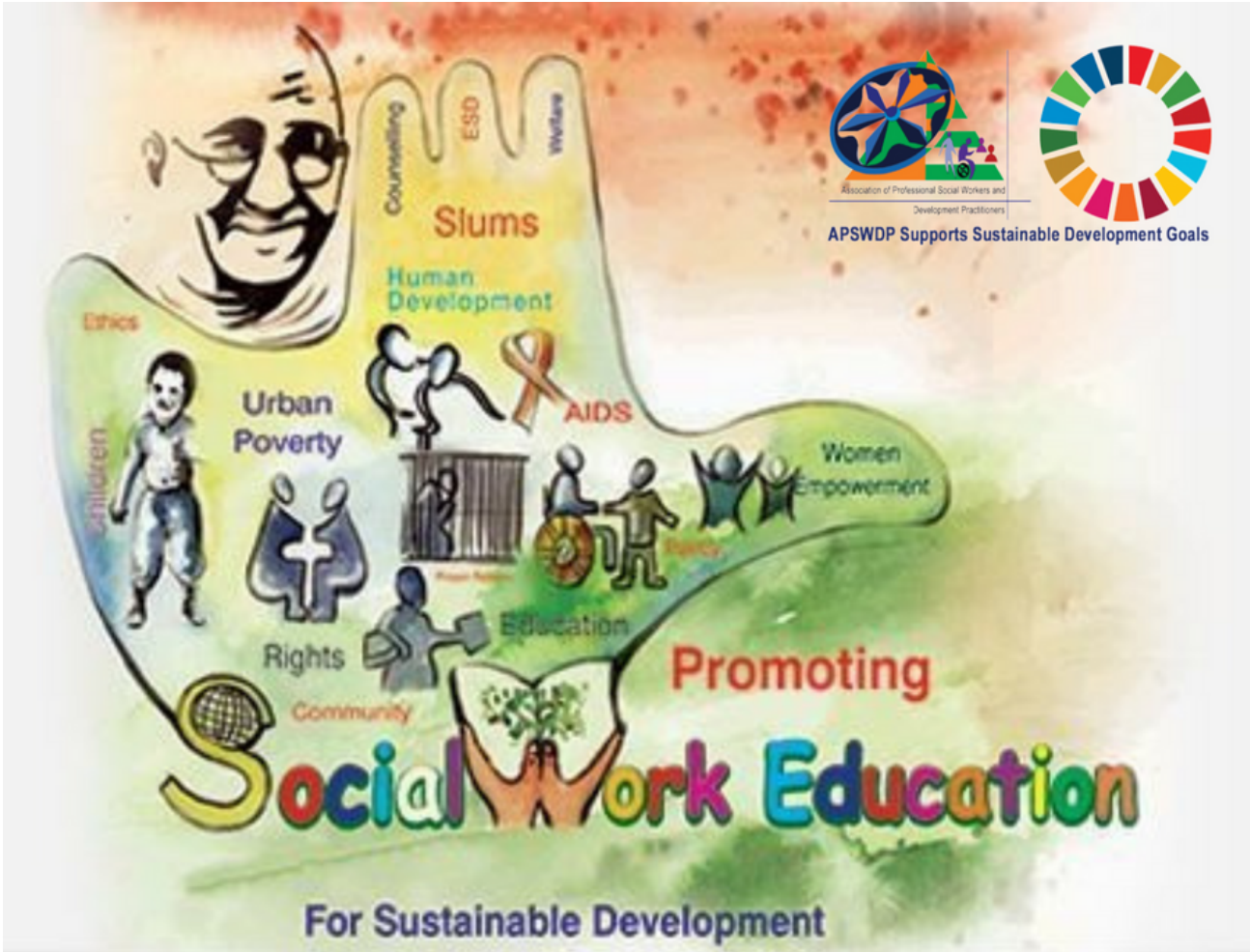

## **BACKGROUND**

Association of Professional Social Workers & Development Practitioners (APSWDP) is a registered not for profit organization of professional social workers and development practitioners working in various social welfare domain across the country. Social issues like poverty, livelihood, health, education, water & sanitation, unemployment, disease control programs, urbanization, youth issues of de-addiction, and others have covered the whole gamut of government, development agencies, and academic institutions. Since the influx of specialization and expertise has increased over the current decade in the country among implementation agencies, the requirement of trained social work professionals and practitioners is indeed a factual requirement.

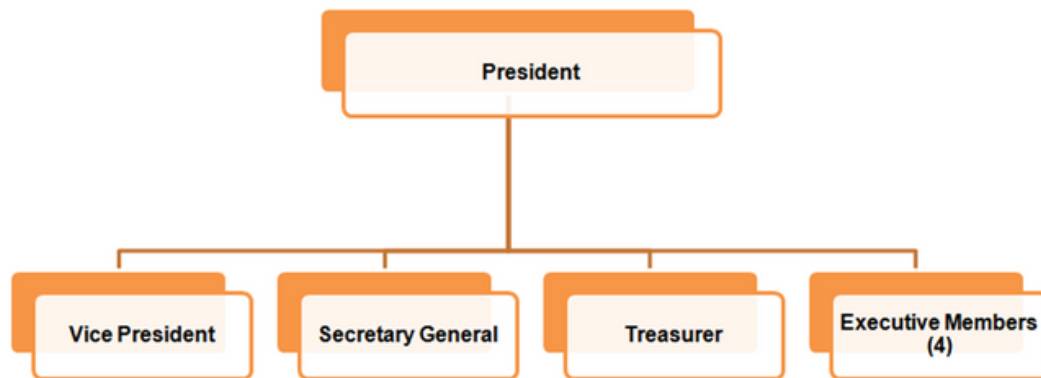
The association focuses on creating a country-wide and global network of dedicated social work professionals and development practitioners from remote geographical rural areas, to discuss, debate, and develop a key framework for evidence & practice-based interventions, and methods. The focus will be to enable social workers and development practitioners all around the globe to share their ideas and work on various development issues. APSWDP will also offer a platform to youth leaders, and scholars/researchers with a striving passion to participate in bringing reformation through correctional measures in existing policies.

## **GENESIS**

Association of Professional Social Workers & Development Practitioners (APSWDP) was founded initially by a group of professional social workers working in development sectors. It primarily started with a popular online social forum 'Alliance of Social Work & Development Practitioners' on the occasion of 65th Republic Day 2014 i.e. 26th January 2014. The forum productively stretched to BSW and MSW learners of Indira Gandhi National Open University (IGNOU) with support from Regional Centre Chandigarh. An orientation program-cum-workshop was organized jointly by the Forum of Professional Social Workers coinciding World Social Work Day and Month for the first time at Chandigarh involving research scholars, learners, civil society, and line departments on 29th March 2014. It was felt during the workshop at the regional center that the forum must be taken to a next higher level by attaining legal status.

On 1st December 2014, World AIDS Day, the online forum received its legal status as an association under the Society Registration Act 1860 as 'Association of Professional Social Workers & Development Practitioners (APSWDP)'. The current President, Vice-President, Secretary General, and Treasurer of the association are Dr. Sumit Arora, Mr. Sharad Singh, Mrs. Rekha Trivedi, and Mr. Amitoz Dogra respectively.

- Publication of a periodical Technical Journal/ News bulletin on the Social Work and Development sector addressing frontier research and critical analytical techniques on the one hand and best practices in difficult existential situations on the other hand.
- Special emphasis on Trainee Assignments in the form of Syndicate Reports, Individual Assignments, and other instrumentalities with a view to challenging the Trainee's capacity to think and imbibe critical knowledge and skills.
- Converting Research Studies into priced publications, monographs, and reports with a view to sharing project experiences and research outcomes.
- Participation in citizens' advocacy campaigns with a view to bringing about actual improvements on the ground.
- Starting of Research Portals for sharing research outcomes with other researchers and program implementing teams.
- Any other work deemed fit by the Governing Body in Social Welfare domain w.r.t any developmental project, international humanitarian context, international tie-ups with educational institutions, international trusts, organizations including intergovernmental and others.
- Initiate, hold, direct, manage, take part in and contribute to conferences, congresses, meetings, lectures, and demonstrations on any aspect of the Social Work Profession and social welfare for the purpose of advancing any of the objectives of the association.
- Hold an Annual Convention and periodic meetings or conferences, CME of members of the association and of the social work and social development profession in general.
- The association can join/partner with any global forum and federation or allied Federations.
- The association can establish its own academy, university, or institute in the future.

### **APSWDP VIRTUAL Introductory and Induction Meeting for members of executive body**

Association of Professional Social Workers and Development Practitioners (APSWDP) organized a Virtual Introductory and Induction Meeting for members of the third newly nominated Governing and Executive Body constituted by the General Body on 26th January 2021.

In the meeting, outgoing Governing Body Members of the APSWDP welcomed and introduced Dr. Sumit Arora, President, and Mr. Hitesh Kumar Gulati, Hon. Director-General APSWDP to all the members present. Later, the outgoing members handed over the steering of the Introductory and Induction Meeting to the President and Hon. Director-General.

Mr. Hitesh Kumar Gulati introduced all the nominated members of the Executive Body including Hon. Directors, APSWDP Special Representatives to UN Offices and Chief Coordinators (Zones) in addition to self-introduction round. Dr. Sumit Arora, President APSWDP, explained the roles and responsibilities to newly inducted team members. He further explained in detail, how the members can plan, lead and contribute to developing their assigned verticals. He also felicitated a session on identifying key strengths and the expertise of team members in preparing a three-year Road Map of APSWDP.

### **Commemorating World Social Work Day, Social Work Month and International Day of Happiness – 2021**

Association of Professional Social Workers and Development Practitioners (APSWDP) Chandigarh in partnership with the State Legal Services Authority (SLSA), Chandigarh, Department of Social Work, CBLU, Haryana, and TCRP-India has conceived and organized World Social Work Day (WSWD) 2021, Social Work Month and International Day of Happiness (IDH) 2021 followed by various training workshops for diverse stakeholders on Community Driven Development through convergence under the ambit of Sustainable Development Goals (SDGs).

APSWDP has pioneered in commemorating WSWD for the 6th consecutive year and introducing its first commemoration of IDH in the North region. The main aim was to promote the values of Theory to Practice and Volunteerism to Professionalism.

WSWD is celebrated on the 3rd Tuesday every year and has become a focal point in the social work calendar with social workers all over the world celebrating and promoting the contributions of the profession towards individuals, families, communities, and wider society. This year, the 2021 World Social Day highlights Ubuntu: I am Because We Are. This is the first theme of 2020 to 2030 Global Agenda for Social Work and Social Development. Ubuntu: I am Because We are – Strengthening Social Solidarity and Global Connectedness.

## **GLIMPSE OF KEY PROGRAMS & EVENTS – ORGANISED (2020 – 2023)**

The IDH is a way to recognize the importance of happiness in the lives of people around the world. In 2015, the UN launched the 17 SDGs, which seek to end poverty, reduce inequality, and protect our planet – three key aspects that lead to well-being and happiness. The resolution was initiated by Bhutan, a country that recognized the value of national happiness over national income since the early 1970s and famously adopted the goal of Gross National Happiness over Gross National Product.

The Social Work Month has been kicked off at Chandigarh under the auspices of SLSA, U.T., Chandigarh, and TCRP-India on 13th March 2021 at Judicial Academy, Chandigarh.

During the inaugural, Shri Mahavir Singh, Member Secretary, SLSA, said that there is a great need to network and develop linkages with Stakeholders in order to ensure Community-Driven Development.

Shri Vikas Verma, Regional Head, SDGCC, UNDP in his address elucidated that universality of the United Nations Sustainable Development Goals through convergence is required at the community level so as to understand the theme ‘Leave no one behind.

In the second event in the Social Work month, two days training workshop on “Community Driven Development through Effective Management of Area Level Federation (ALFs)/City Level Federation (CLF) and Sustainable Development Goals” was organized by the APSWDP in partnership with Development Cell of the Municipal Corporation Chandigarh on 16th-17th March 2021 at Rajiv Gandhi National Institute of Youth Development, Sector 12-A, Chandigarh under the aegis of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM), Municipal Corporation, Chandigarh.

The two-day training workshop was inaugurated by Sh. Ravi Kant Sharma, Mayor, Municipal Corporation, Chandigarh as Chief Guest and Sh. Rahul Priyadarshi, General Manager and Regional In-charge, SIDBI as Guest of Honour.

In the last event conceived in Social Work month, a one-day training workshop on Community Driven Development and SDGs was organized in institutional partnership with the Department of Social Work, Chaudhary Bansi Lal University (CBLU), Bhiwani, Haryana on 20th March 2021, which was inaugurated by Chief Guest Prof. R. K. Mittal Vice-Chancellor CBLU, Bhiwani and Guest of Honor Sh. Aditya Pundir, Head South Asia, The Climate Reality India in presence of Prof. Vikas Kumar Head Social Work Department.

The key objectives of these events was to strengthen cooperation and partnership with diverse organizations and stakeholders, to spread knowledge about social work, its values, principles and methods in practice and theory among organizations and departments, to highlight social work actions, policies and achievements in the pursuit of common goals and finally to disseminate the knowledge about SDGs, community workers and social work organizations, institutions, etc.

The futuristic goals are to converge and develop linkages with Social Work Professionals to work in coherence for resolving human conflicts in the communities, promoting Community Driven Development on the principles of participation, local empowerment, demand-responsiveness, greater accountability, and enhance local capacity through transparency, mainstreaming of various CSOs and NGOs to lead the local chapter in the region, and emphasizing on sustainable lifestyle for bringing happiness in the community.

### **MOU Signing between apswdp and CBLU, BHIWANI, HARYANA.**

A Memorandum of Understanding (MOU) was signed between the Association of Professional Social Workers and Development Practitioners (APSWDP) Chandigarh, India, and Chaudhary Bansi Lal University, Bhiwani, Haryana on 20th March 2021 for the Promotion of Social Work Education for Sustainable Development and organizing various collaborative programs in Social Welfare, Management, and Social Work domain. Jitender Kumar Lohia immediately after successful completion of Virtual Internship program and participation of founder APSWDP in various programs of CBLU organized by Department of Social Work during COVID-19 Pandemic.

The signing of MOU was felicitated by Prof. Vikas Kumar, Head, Department of Social Work, CBLU, Bhiwani on behalf of Registrar, CBLU, Bhiwani in a meeting held with Sh. R. K. Mittal, Hon. Vice-Chancellor on the occasion of commemorating World Social Work Day 2021 on 20th March, 2021.

## **GLIMPSE OF KEY PROGRAMS & EVENTS – ORGANISED (2020 – 2023)**

### **Virtual Teachers Training and Green Campus Programme in the background of World Earth Day- 2021 on 12 and 17 April 2021**

A Virtual Teachers Training and Green Campus Programme was organized by the APSWDP in partnership with Chitkara University, Punjab Campus under the aegis of 'The Climate Reality Project-India' on 12th and 17th April 2021 to commemorate 'World Earth Day 2021'. The training program was inaugurated by Shri Aditya Pundir, Head-India, and the South Asia, The Climate Reality Project. The training was attended by 100 participants including aspiring teachers, academicians, and researchers from the university.

### **Launch of Virtual Center of Excellence for Social Welfare Administration on 30 April 2021**

APSWDP while following its Vision & Objectives as well as the learnings from COVID-19 Pandemic established a Virtual Center of Excellence for Social Welfare Administration (VCoE-SWA) with the following three key objectives:

1. to meet an enormous unmet need of social welfare, social development, NGO/CSO/CBO/NPO sector, and the society at large that can be met through capacity building, training, and capability development of human resources engaged in the Social Sector;

Roughly, India has a population of 4.8 million transgender persons as per Census 2011. ## ACCREDITATIONS & AFFILIATIONS

The Association of Professional Social Workers and Development Practitioners (APSWDP) has been accredited with the following credible inter-governmental institutions of national and global importance:

### 1. United Nations Special Consultative Status under Economic and Social Council (ECOSOC).

The Economic and Social Council (ECOSOC) was established by the United Nations Charter as the principal organ, under the authority of the General Assembly, to promote:

- a. higher standards of living, full employment, and conditions of economic and social progress and development;
- b. solutions of international economic, social, health, and related problems; and international cultural and educational cooperation; and
- c. universal respect for, and observance of, human rights and fundamental freedoms for all without distinction as to race, sex, language, or religion.

Under the Charter, the Economic and Social Council may consult with non-governmental organizations (NGOs) concerned with matters within the Council's competence. The Council recognized that these organizations should have the opportunity to express their views and that they possess special experience or technical knowledge of value to the Council's work. Under ECOSOC resolution 1996/31, NGOs that wish to consult with ECOSOC on certain matters may seek and be granted consultative status to facilitate this work.

#### Consultative Status

The basis for the consultative relationship between the United Nations and non-governmental organizations was set forth in the mid-nineties following an extensive intergovernmental review that culminated in ECOSOC Resolution 1996/31. This relationship is the principal means through which ECOSOC receives input from NGOs into its deliberations at public meetings and in its subsidiary bodies as well as in UN international conferences and their preparatory bodies. Each year the approximately 3500 NGOs now holding consultative status receive the provisional agenda of ECOSOC. They have certain privileges to place items on the agenda of ECOSOC and its subsidiary bodies; they may attend meetings, where they may submit written statements and make oral presentations to governments.

The UN Committee on Non-Governmental Organizations is a standing committee of the ECOSOC. Its mandate is set out in ECOSOC Resolution 1996/31.

## ACCREDITATIONS & AFFILIATIONS

The main tasks of the committee are:

- a.the consideration of applications for consultative status and requests for reclassification submitted by NGOs.
- b.the consideration of quadrennial reports submitted by NGOs in General and Special categories.
- c.the implementation of the provisions of Council Resolution 1996/31 and the monitoring of the consultative relationship.
- d.any other issues which the ECOSOC may request the Committee to consider.

### **2. Affiliated with the Department of Global Communications (DGC) of the United Nations.**

The Department of Global Communications, previously known as the Department of Public Information (DPI), was established in 1946, by General Assembly resolution 13 (I), to promote global awareness and understanding of the work of the United Nations.

### **3. Registered with European Commission (E.U.) as an Expert under Research and Innovation Programs.**

The European Commission is the EU's executive arm. It takes decisions on the Union's political and strategic direction. The Association of Professional Social Workers and Development Practitioners (APSWDP) is registered as an expert under research and innovation programs.

### **4. Registered under the National Institution of Transforming India (NitiAyog- former Planning Commission of India).**

The National Institution for Transforming India, also called NITI Aayog, was formed via a resolution of the Union Cabinet on January 1, 2015. NITI Aayog is the premier policy Think Tank of the Government of India, providing both directional and policy inputs. While designing strategic and long-term policies and programs for the Government of India, NITI Aayog also provides relevant technical advice to the Centre and States.

The Government of India, in keeping with its reform agenda, constituted the NITI Aayog to replace the Planning Commission instituted in 1950. This was done in order to better serve the needs and aspirations of the people of India. An important evolutionary change from the past, NITI Aayog acts as the quintessential platform of the Government of India to bring States to act together in the national interest, and thereby foster Cooperative Federalism.

At the core of NITI Aayog creation are two hubs. Team India Hub and the Knowledge and Innovation Hub. The Team India Hub leads the engagement of states with the Central government, while the Knowledge and Innovation Hub builds NITI's think-tank capabilities. These hubs reflect the two key tasks of the Aayog.

NITI Aayog is also developing itself as a State of Art Resource Centre, with the necessary resources, knowledge, and skills, that will enable it to act with speed, promote research and innovation, provide strategic policy vision for the government, and deal with contingent issues.

Through its campaigns, particularly World Environment Day, UNEP raises awareness and advocates for effective environmental action.

Headquartered in Nairobi, Kenya, UNEP works through its divisions as well as regional, liaison and out-posted offices and a growing network of collaborating centres of excellence.

UNEP works closely with its 193 Member States and representatives from civil society, businesses, and other major groups and stakeholders to address environmental challenges through the UN Environment Assembly, the world's highest-level decision-making body on the environment.

### **6. Observer Status with United Nations Environment Assembly (UNEA).**

The United Nations Environment Assembly is the world's highest-level decision-making body on the environment. It addresses the critical environmental challenges facing the world today. Understanding these challenges and preserving and rehabilitating our environment is at the heart of the 2030 Agenda for Sustainable Development.

The Environment Assembly meets biennially to set priorities for global environmental policies and develop international environmental law. Through its resolutions and calls to action, the Assembly provides leadership and catalyses intergovernmental action on the environment. Decision-making requires broad participation, which is why the Assembly provides an opportunity for all peoples to help design solutions for our planet's health.

### **7. UNESCO MIL ALLIANCE**

The UNESCO MIL Alliance, formerly known as Global Alliance for Partnerships on Media and Information Literacy (GAPMIL), is a groundbreaking effort to promote international cooperation to ensure that all citizens have access to media and information competencies. ### **8. United Nations Framework Convention on Climate Change (UNFCCC)**

The United Nations Framework Convention on Climate Change (UNFCCC) established an international environmental treaty to combat "dangerous human interference with the climate system", in part by stabilizing greenhouse gas concentrations in the atmosphere. It was signed by 154 states at the United Nations Conference on Environment and Development (UNCED), informally known as the Earth Summit, held in Rio de Janeiro from 3 to 14 June 1992. It established a Secretariat headquartered in Bonn, Germany, and entered into force on 21 March 1994. The treaty called for ongoing scientific research and regular meetings, negotiations, and future policy agreements designed to allow ecosystems to adapt naturally to climate change, ensure that food production is not threatened, and enable economic development to proceed in a sustainable manner.

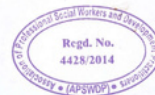
